 - 14.1.2. one (1) full-day workshop, held by such members of CNN, as determined by Turner in its absolute discretion, which shall consist of each Participant helping to create a newscast.
 - 14.1.3. selected meals as determined by Turner in its absolute discretion throughout the Event Date;
- 15.Before being selected the potential Participant may be required to prove eligibility, including, without limitation, proof of age, residence, identity, which may include but is not limited to a copy of proof of residence, passport and/ or similar government issued identification.
